## CANBERRA THEATRE EXCURSION:

**PLAY INFORMATION:** The play is an adaption of Jane Austen's novel, "Sense and Sensibility". There will be time after the production for a Q and A with the cast. This excursion will be of particular interest to those students who have participated in the "Tea with Jane Austen" Enrichment class, have an interest in the works of Jane Austen and/or are in English Extension classes.

**COST:** Free for students

**DEPARTURE:** Friday 1 June – 10.30am

**RETURN:** National 1 June – 2.30 pm return to school in time for buses

**TRANSPORT:** Walking

**CATERING:** Students need to bring their own lunch on the day or can purchase lunch at the food hall in the Canberra Theatre. Please note that students are responsible for their own money and all other valuables taken on this excursion.

**MATERIALS REQUIRED:** Hat and sunscreen for the walk, appropriate footwear and full school uniform.
